4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause mild to severe irritation with possibility of permanent eye damage. After skin contact: Repeated or prolonged excessive exposure may cause irritation. After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur. 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Wear skin, eye and respiratory protection as recommended in Section 8. Stop leak if you can do it without risk. Spills present a slipping hazard. Keep unnecessary personnel away. Ventilate spill area if possible. Make sure area is slip-free before re-opening to traffic.
