4. FIRST AID MEASURES

Description of necessary measures

Inhalation: Remove from exposure area to fresh air. Treat symptomatically and supportively. Asthmatic-type symptoms may develop and may be immediate or delayed up to several hours.

Skin contact: First aid measures not required. Cosmetic product and therefore not necessary.
